Shepherd University has a strong commitment to excellence in education. To assure that all teachers may register for needed or desired classes, Shepherd University maintains a low tuition rate for Professional Development (EDPD) courses. The tuition is \$66.00 per credit or \$198.00 for each 3 non-degree credit graduate-level EDPD class.

VESI tuition is \$66.00 per credit and requires an additional \$150.00 fee for the use of their software and professors (\$282.00 for 2-credit class and \$348.00 for 3-credit class).

Calmer Schools tuition is \$66.00 per credit and requires an additional \$150.00 fee for the use of their software and professors (\$348.00 for 3-credit class).
